

**Notification for Eligibility Test (ET) for  
Post Qualification Course on Information Systems Audit (ISA)  
on Saturday the 12<sup>th</sup> November, 2016**

*Last Date for Online Form Submission 31<sup>st</sup> October, 2016 till 5:30 PM*

1. The next Eligibility Test for ISA PQC is scheduled to be held on Saturday the 12<sup>th</sup> November, 2016 from 10:00 a.m. to 02.00 p.m. for old syllabus and 10.00 a.m. to 12:30 p.m. for new syllabus.
2. This time ISA Eligibility Test will be held through **online mode**. A detailed notification giving list of centers and a demo link for demonstrating the Online Eligibility Test would be hosted on Committee Portal at <http://cit.icaai.org>.
3. Status of candidates, who have completed ISA Professional Training from 1<sup>st</sup> April, 2016 to 30<sup>th</sup> September, 2016, would also be updated by 15<sup>th</sup> October 2016. In case you do not find your status updated, kindly forward your request giving requisite details (ISA No, Membership No., Name, ISA PT Date and City) to [isa@icaai.org](mailto:isa@icaai.org)/[isa1@icaai.in](mailto:isa1@icaai.in), by 18<sup>th</sup> October, 2016.
4. Candidates desirous of taking this ISA ET have to submit the Online ISA ET Form (by giving their ISA No. and password) that would be available on the Committee Portal at <http://cit.icaai.org> from 15<sup>th</sup> October, 2016 to 31<sup>st</sup> October, 2016.
5. ISA Eligibility Test November, 2016 will be conducted with both revised (as effective from 1<sup>st</sup> July 2014) and old syllabus. Members, who have completed PT Classes by 30<sup>th</sup> June, 2014 will be required to take exam in old syllabus and members who have undergone ISA PT classes for ISA Course 2.0, will be required to take exam as per new syllabus.
6. Candidates filling form B or C (2<sup>nd</sup> or subsequent attempt) have to pay ISA ET Fee of Rs. 500/- (Rupees Five Hundred only). Members can make online payment through the link available on CIT Portal while filling the online ET Form. Members can also pay through Demand Draft/ Pay Order in favour of "The Secretary, ICAI", payable at Delhi and it should reach at the following address latest by 31<sup>st</sup> October, 2016.
